<b>Entry Restrictions</b>	<p>Entrants must purchase a General Admission Adult Ticket to the 2023 Birdsville Races <i>and</i> register for the 2023 Birdsville Races Roadies before 15 July 2023 for a chance to win.</p> <p>Entrants must be over 18 years of age to be eligible to enter.</p>
<b>Competition Period</b>	<p>The Competition begins at 8am on Monday 10 July 2023.</p> <p>Entries into the Competition close at midnight Saturday 15 July 2023 AEST.</p>
<b>Entry Method</b>	<p>The Birdsville Races Ticket competition will be launched across Birdsville Races (and associated) channels.</p> <p>During the Competition Period, Eligible Entrants can purchase a ticket from the OzTix website. They must also register for the Birdsville Races Roadies on the Birdsville Races website.</p>
<b>Maximum number of entries</b>	Each Birdsville Races ticket purchase together with a Birdsville Races Roadies entry counts as 1 (one) entry to the Birdsville Races Ticket Competition.

#### **Birdsville Race Club Inc Promotion: Game of Chance – Terms and Conditions of Entry**

#### **Eligibility to Enter**
